ORDER

The Court, having received a recommendation from the Administrative Conference to appoint a standing committee on juries; and upon further recommendation as to committee membership, a Jury Committee is hereby appointed to perform the following tasks:

- Evaluate the current jury system and make recommendations to the Court for needed reforms in the jury system of the State of Idaho.
- Review statutes, rules, and statewide publications including the Jurors Handbook, Guide to Deliberations and jury service pamphlet and recommend any necessary amendments.
- Research and identify technology that may provide for efficiencies in jury operations (e.g. new features in jury management software, court websites, orientation videos, social media).
- Make recommendations to address the difficulties that modern technology (such as texting, inappropriate use of social media, mobile access to the internet, etc.) may present in trial management.
- Make recommendations relating to best practices in jury management, including improving the juror experience, juror pay, maximizing juror yield, juror utilization, meeting juror needs, and privacy.
- Make recommendations relating to juror education and public outreach, as well as training for judges and court personnel.
- Increase awareness of the importance of the jury system—as well as the public's participation in that system—and develop strategies to improve jury service and appreciation.

IT IS FURTHER ORDERED that the Jury Committee shall meet regularly and shall report periodically to the Court and to the Administrative Conference on actions taken as well as recommendations for improvements to the jury system.
